- <sup>1</sup> A single Medicare Advantage contract may include more than one D-SNP, and may also include other SNP types and non-SNP Medicare Advantage plans.
- <sup>2</sup> A new D-SNP contract for purposes of this table is a contract that includes one or more D-SNP plans in the preliminary CMS SNP Landscape Source Files for CY 2016 for a specific state, but that is not included in the September 2015 SNP Comprehensive Report for that state. A departing D-SNP contract is one that includes one or more D-SNP plans in September 2015, but that is not included in the preliminary SNP Landscape Source Files for CY 2016. In some cases, as noted in footnotes below, a company with a departing D-SNP contract may be operating other non-departing contracts in the state that include D-SNP plans. The preliminary CMS SNP Landscape Source Files that were released on September 21, 2015 may not include final information on the D-SNP contracts that will be operating in January 2016 if that information was not available by the September 9, 2015 cut-off date for these files. For purposes of this table, a large Service Area Reduction (SAR) is one in which over 50 enrollees are affected.
- <sup>3</sup> Five plans spanned across multiple states. In this table, we divided the number of enrollees in those plans evenly across the states and added the plan to each state's total number.
- <sup>4</sup> The Number of Enrollees Affect by Service Area Reductions is from July 2015 data.
- <sup>5</sup> Mercy Care (Southwest Catholic Health Network Corporation) operates other D-SNPs in Arizona under Contract Number H5580.
